

A Directory of State-specific Record Clearing Resources

This resource includes information for at least one organization in every state and the District of Columbia that provides free or low-cost record-clearing services in that state. Whenever possible, links to self-help resources and applicable forms have also been provided.

Please note:

- Many of the organizations listed cover multiple cities or counties, and some cover the entire state. That information should be available on the organization's website. Eligibility for organizations with geographic limits is typically based on where you live at the time you apply for services, but in some cases may be based on the jurisdiction where the criminal case originated.
- The address provided is a mailing address, PO Box, or administrative office address (when applicable). If no primary address was found, the specific office name is listed with the local address.
- Many of the organizations do walk-in intake. Hours and guidelines should be on their website.
- The majority, but not all, of the organizations listed here offer free legal services for people who fall under 125%–200% of the federal poverty guidelines. The 2025 guidelines are included in the [Appendix](#).
- The majority of the organizations listed here receive LSC funding. Organizations that receive LSC funding are not permitted to provide legal services to undocumented people.
- When available, an intake hotline reserved for people over the age of 60 is included in this resource.
- This resource does not cover every legal aid/record-clearing resource in every state; there may be additional organizations that provide services. Criteria for inclusion in this resource were either listing criminal record clearing as an area of service or using language on the webpage that implied it would be provided. Services that did not meet this criterion were deliberately excluded.
