Dear (FY08 State-Foreign Operations Appropriations Conferee):

We are writing to urge the State-Foreign Operations Appropriations Conference Committee to maintain the \$461 million funding level for bilateral family planning and reproductive health programs included in the Senate's version of the bill and to adopt the \$40 million contribution for the United Nations Population Fund contained in the House bill. Ensuring funding at these levels is a critical first step in improving the health of tens of millions of women and men in the developing world who lack access to basic reproductive health care.

Much of the funding in the development assistance account yields benefits across several areas outside the core funding stream. Family planning and reproductive health services are among the investments yielding the broadest impact in numbers of lives saved and in improved health. Yet when adjusted for inflation, current U.S. bilateral funding for family planning and reproductive health programs is 41% less than in FY 1995. At the same time these steep funding reductions have taken place, the number of women of reproductive age in the developing world alone has increased by approximately 275 million women.

Family planning and reproductive health programs are important in their own right and because of the multiple benefits realized by families and communities beyond the direct services provided. These funds:

- provide services and contraception to enable people to choose when to become pregnant and to have the number of children they want and can support;
- reduce unintended pregnancies and consequently the number of abortions;
- promote healthy pregnancies and births;
- improve the health of infants and children;
- enable increased prevention and testing for sexually transmitted infection, including HIV, and referrals into treatment and care;
- ease pressure on natural resources, and help families better meet basic needs for water, food, and energy; and
- in the longer term help promote social, economic and political stability.

These benefits warrant the minimal but critical increase called for by the Senate. In fact, without the additional investments in family planning and reproductive health programs provided in the Senate bill, we will continue to fall behind in the effort to improve global health.
